**EXPANSION OF THE COEGA SPECIAL ECONOMIC ZONE TO ESTABLISH A  
PHARMACEUTICAL AND VACCINE PRECINCT**

I, Parks Tau, Minister of Trade, Industry and Competition, hereby publish for public comment in terms of section 24(1) of the Special Economic Zones Act No. 16 of 2014, the proposed expansion of the Coega Special Economic Zone boundary of 9003 hectares to include 8.3138 hectares, which land area is bordered on the north by erf 3256; 1,1 hectares of the remainder of erf 3278 and 7,2 hectares of erf 2892; in the south by Harrower Road; in the west by Kempston Road and in the east by Gibson Road within the Nelson Mandela Bay Municipality as is further set out in the table listing the erven numbers and a map indicating the boundaries of the Special Economic Zone in the annexures hereto.

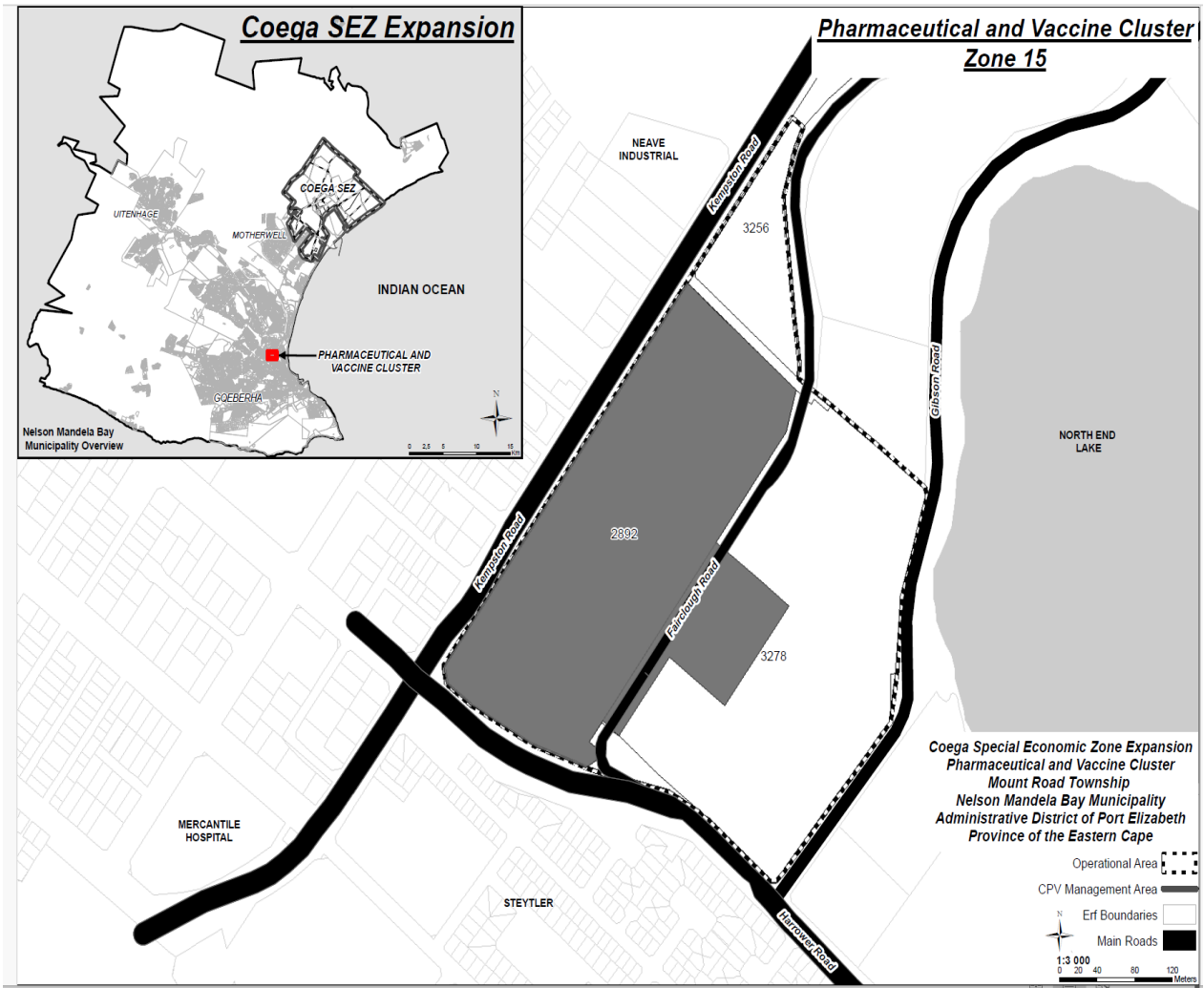
